1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, as the Company has executed the sale of its loss-making Tanzanian coal business and is only awaiting the necessary shareholder and Tanzanian regulatory approvals to complete the transaction expected to take place in February 2022. In addition, a significant portion of the operational payments in the current quarter were in settlement of accrued liabilities arising in previous financial periods, following the inflow of capital raising funds and receipt of instalment 1 from the sale of the Tanzanian coal business during the current quarter.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Tranche 2 placement for A\$1,500,000 (gross) expected to be approved at the February EGM, 2nd instalment from sale of Tanzanian coal business of USD1m expected to be received in February after shareholder approval for the sale is given at the EGM

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, on the basis of the Company's proven ability to be able to raise capital on the ASX and on the back of recently acquired exploration projects based in Australia.
