Pursuant to a Facility Agreement with KCB Bank Tanzania Limited (KCB) dated 22 June 2022, two USD terms loans and a USD overdraft facility with KCB were consolidated into single secured term loan totalling USD942,000 (\$A1,365,000). The loan is repayable over 36 months inclusive of a 6-month moratorium period. Interest is charged at an effective rate of 8% per annum. The USD spot rate at 30 June 2022 was 0.6904199602 and the TZS spot rate at 30 June 2022 was 0.000621322. \*

The impact of the loan consolidation on cash flow during the quarter per point 3.9 above, comprises the consolidation into the loan facility, of the KCB bank overdraft plus capitalisation of accrued interest and KCB negotiation fees.

Mirambo Holdings Limited (purchaser of the Tanzanian coal business) provided working capital advances of A\$745,000 during the current quarter. Total advances to date amount to A\$909,000 \*

No other additional financing facilities were entered into during the quarter or are proposed.

\* These facilities relate to the Tanzanian coal business and will be deconsolidated from the IEC Group under Australian Accounting Standards on completion of the sale transaction as discussed at item 8.8.1 below.

Answer:

No, as the Company has executed the sale of its loss-making Tanzanian coal business and is only awaiting the necessary Tanzanian regulatory approvals to complete the transaction expected to take place in the following quarter.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

The 2<sup>nd</sup> instalment from sale of Tanzanian coal business of USD1m expected to be received in the following quarter after shareholder approval for the sale was obtained at the February 2022 EGM.

In addition, the Company intends to raise further capital through a placement to be completed in the quarter ending 31 December 2022.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, on the basis of the Company's proven ability to be able to raise capital on the ASX and on the back of the exploration results from the Company's projects based in Australia.
